An unlicensed restaurant has been run by a different proprietor in this premises. The applicant took over the premise a year ago and has been running the business since that time.

The application is such that there will be no additional impact on the area as a result of the granting of this liquor licence.

By virtue of the fact that the premises are located to the west of Johannesburg and in the Melville area the applicant's premises draws its clientele from the business sectors of the western suburbs of Auckland Park, Melville, Northcliff, Emmarentia and Victory Park and areas surrounding the premises. In addition, businessmen and families in the evenings are drawn from all of these and other residential areas.

The restaurant is constructed in such a manner that it does not cause any interference to any of the residents in the area. This is particularly so as the nearest residents are all located behind the premises at least 200 metres away. The restaurant itself faces onto the two main roads and is located on the corner.

THE RESTAURANT ITSELF

It will be noted that the restaurant comprises a sit-down area and a small outside area overlooking the street with the necessary kitchen and toilet facilities.

The dining area will seat approximately 60 people at wooden chairs with padded seats with wooden tables. There are also concrete benches with cushions along the left hand wall.

The applicant's premises are well supported by the public. The applicant took over these vacant premises after they were closed by the previous tenant.

They have been running this business for a year and it has been extremely successful. It is a considerable amount of trade in the Melville area and many of the people from the other restaurants will utilise the facilities of the applicant. The applicant also has a following from being involved in various businesses and the business world where the director of the applicant has built up any number of contacts. This is in addition to the following which will be built-up by the applicant as a result of the fare of the restaurant.

There were no incidents regarding the sale of liquor. As this is a sophisticated restaurant liquor is a major part of the applicant's business. It will be noted from the menu that the applicant has an expensive fare and accordingly people visiting the premises are not prepared to bring their own liquor. They expect the applicant to have the facility of the sale of liquor in the business.

Approximately 60/80 meals are served per day at approximately R120,00 to R150, 00 per head.

The restaurant is a restaurant built from scratch and a high-class establishment and only the best materials and furnishing are being used throughout. The replacement cost of the restaurant would be in excess of R700 000.00.

The atmosphere of the restaurant, as is indicated by its name, is similar to that of the other semi-formal restaurants in the Melville area, most of which have already been granted liquor licences.

The management of the business (being the member of the applicant and a full time manager who previously ran a Melville restaurant) are involved in the running of this business and in particular the establishment of this business.

The furnishings and decor in the restaurant, the menus, sauces, food, preparation methods and the like are similar to those used by other Melville restaurants with a casual slant.

For convenience, a copy of the menu to be used at the operation is annexed to this application.

The furniture and decor of the restaurant is modern wood with panelling and decorations and the crockery is continental china with stainless steel cutlery.

THE APPLICANT

The applicant is a company comprising one director.

She has been involved in the business world since she started working and is employed in the business sector. She initially started this restaurant on the basis that she will continue to work in her present employment and the restaurant will be run by a manager. She is now full time in the restaurant as it has taken off and is successful.

By virtue of her financial background she is clearly capable of running this business and all of the financial and other aspects.

She has sourced a manager who was employed at one of the other restaurants in Melville and left that position to run this business in conjunction with her. The manager obviously has a following and attracted a number of people to the restaurant because of their past association with her.

The Director is in day to day direct control of the restaurant and will be able to control all financial aspects as well as administration and running aspects by being at the restaurant in the evenings.

The staff at the restaurant comprises the director of the applicant, the manager, 3 waiters on duty at a time and a kitchen staff of 7.

It is submitted that the applicant and its director are fit and proper persons to hold a liquor licence and the approval of the Liquor Board to this application is requested.

SERVICES OFFERED AND SECTOR OF THE MARKET

The services that the applicant offers at this restaurant are similar to those at the other expensive restaurants in Johannesburg. It will be noted that the average spending per head is well over R100,00 and this is higher than the average for the Melville area.

The nature of the service which will be offered will be similar to that offered at sit-down type restaurants in the extended Johannesburg area, particularly those aimed at the adult trade in the area. It is important to note that the applicant has a lounge area which will serve as a waiting area for the restaurant and will prevent the situation where patrons from the restaurant wait outside for a table.

The restaurant is open at both lunchtime and dinnertime and the clientele which the applicant draws its clientele from all of the areas in close proximity to Melville and the various industrial suburbs in the area, offices, businesses and shoppers in the nearby shopping centres during the day and in the

evenings the residents from the above suburbs and the entire Melville, Auckland Park and Victory Park areas.

There will be ample parking in the restaurant parking area for patrons.

The Melville area is developing extremely fast, particularly as regards businesses and office blocks and there is more than enough demand from patrons in the area for a facility such as that which the applicant operates.

THE FEASIBILITY OF THE BUSINESS AND THE NEEDS OF THE COMMUNITY

The premises are located in the Melville area where most of the restaurants are extremely successful. This business has been running for the last year successfully and makes a profit monthly. The grant of a liquor licence will also make a difference both in the restaurant and the quality of clientele.

The applicant has the financial resources to set up this business and to carry the business until such time as it becomes viable. In view of the amount of money which the applicant is spending on the business the staff which is to be employed there is no reason to expect that this business should not be successful.

FORMAL REQUIREMENTS

As this is an application for a liquor licence there are certain formal requirements that the applicant has attended to. Annexed to this application is the required documentation giving proof of the meeting of these requirements :

1. tear sheets from the newspapers in which the advertisement appeared;

2. a copy of the relevant page from the Provincial Gazette;
3. proof of right of occupation of the premises is attached by way of a lease from the landlord;
4. income tax clearance of the applicant;
5. South African Police Clearance of the applicant;
6. membership of association affiliated to Gauteng Liquor Traders Association.

GENERAL

The applicant submits that the facilities which it offers more than adequately meet the requirements of the Liquor Board for a restaurant liquor licence, or such other liquor licence as the Honourable Board, in its discretion, may wish to grant and that there is a substantial demand in this area for the services which it offers.

As regards the applicant and its director and in view of what has been submitted above, it is submitted that the applicant and its director are of good character and are fit and proper persons to hold a liquor licence and that there is no reason why such a licence should, in fact, not be granted.

It is submitted that it is in the interest of the public in the area that this liquor licence be granted, particularly as it is located in extended Melville business node.

These representations will be expanded at the hearing of this application, by way of further written representations, oral representations and the submission of photographs, menus and the like.

DETAILED WRITTEN DESCRIPTION OF THE PREMISES TO WHICH THE APPLICATION RELATES IN TERMS OF SECTION 23(1)(c) OF THE ACT
LOCATION OF PREMISES

The premises are located at :

BREAD AND ROSES RESTAURANT (MELVILLE), SHOP NO.80, 4TH AVENUE, CORNER OF 7TH STREET, MELVILLE, BEING ERF 374 MELVILLE, DISTRICT JOHANNESBURG

The premises are located at the 4th Avenue and 7th Street in Melville. The entrance is on the corner of the building leading directly into the dining area through double glass doors set in wooden frames.

The entire public area has concrete screed floors painted with special paint, walls plastered and painted with acrylic paint and a rhino board ceiling with down lighters and hanging lights.

The downstairs section seats approximately 50 people at wooden tables with cast iron legs and wooden dining room type chairs with padded seats as well as moulded PVC chairs.

To the left of this is a set of three stairs which leads to an upstairs section which is also part of the public area. This upstairs section has banquet seating around the perimeter, concrete seats with padded cushions and backs and wooden free standing chairs as well as wooden tables with metal legs. This area seats approximately 40 people.

To the right hand rear of the premises is an archway which leads through to the toilets which are located at the rear of the premises. To the right hand side of the passageway is a ladies' toilet which comprises a WC and a wash hand basin. The toilet has ceramic tiles on the floors and walls. To the left hand side of the walkway which leads to the men's toilet which comprises a WC and a wash hand basin. It has terracotta tiles on the floors, walls tiled up to approximately 2m plastered and painted with acrylic paint above.

To the rear of this is a walkway which leads to the outside area of the adjacent business.

To the left hand side of the exit from the restaurant to the rear is the staff change room and an office.

On the right hand side of the downstairs side dining area is the kitchen. The kitchen has an open hatch which gives a view of the entire kitchen. The entrance into the kitchen is through a single door into the kitchen itself.

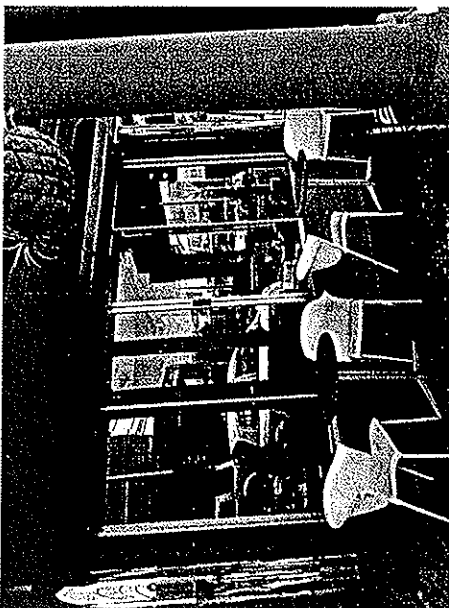
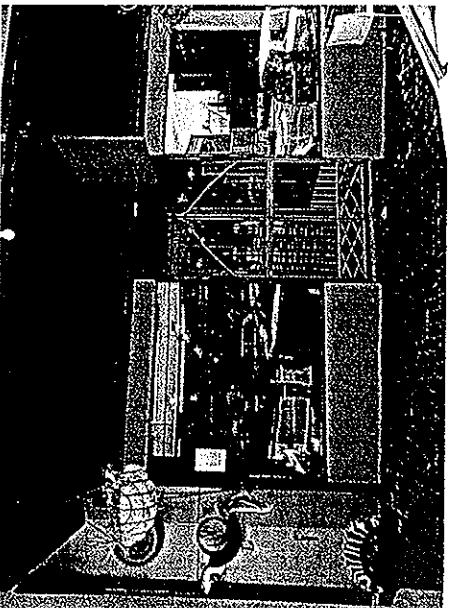
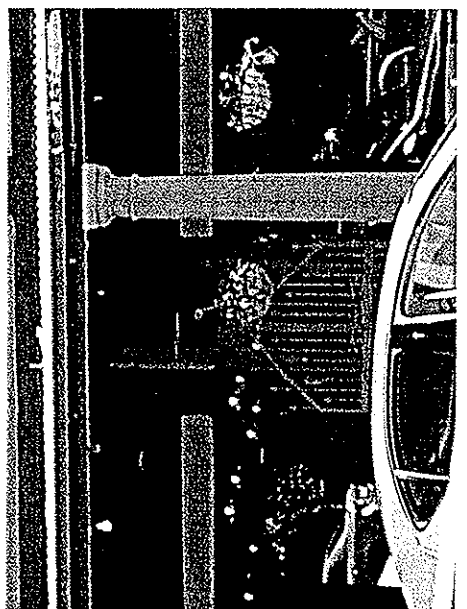
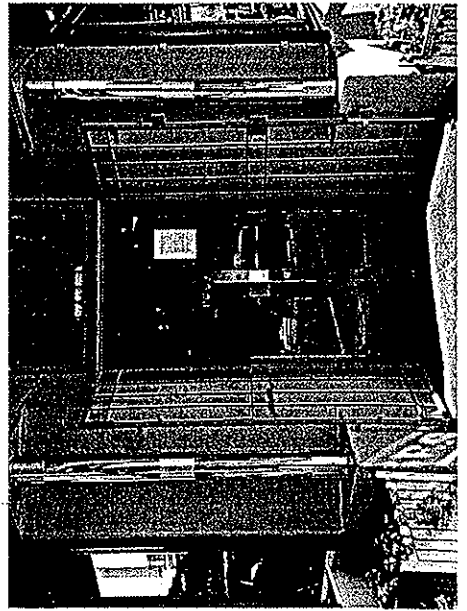
The kitchen has a concrete floor with plasticized finishes, walls tiled with ceramic tiles where required by the municipal authorities and the remainder plastered and painted with acrylic paint.

Directly across the entrance into the kitchen is an extractor canopy with grillers, fryers, stoves etc. below.

To the right hand side of this is an upright fridge as well as under-bar fridges with stainless steel work surfaces. There is also a sink to the left hand side for preparation of food.

To the left hand side of the entrance into the kitchen is a flight of two stairs which leads up to a wash-up area with double bowl stainless steel sink, drying area and shelves for dishes. There is a rear entrance from this part of the kitchen to the service areas at the back.

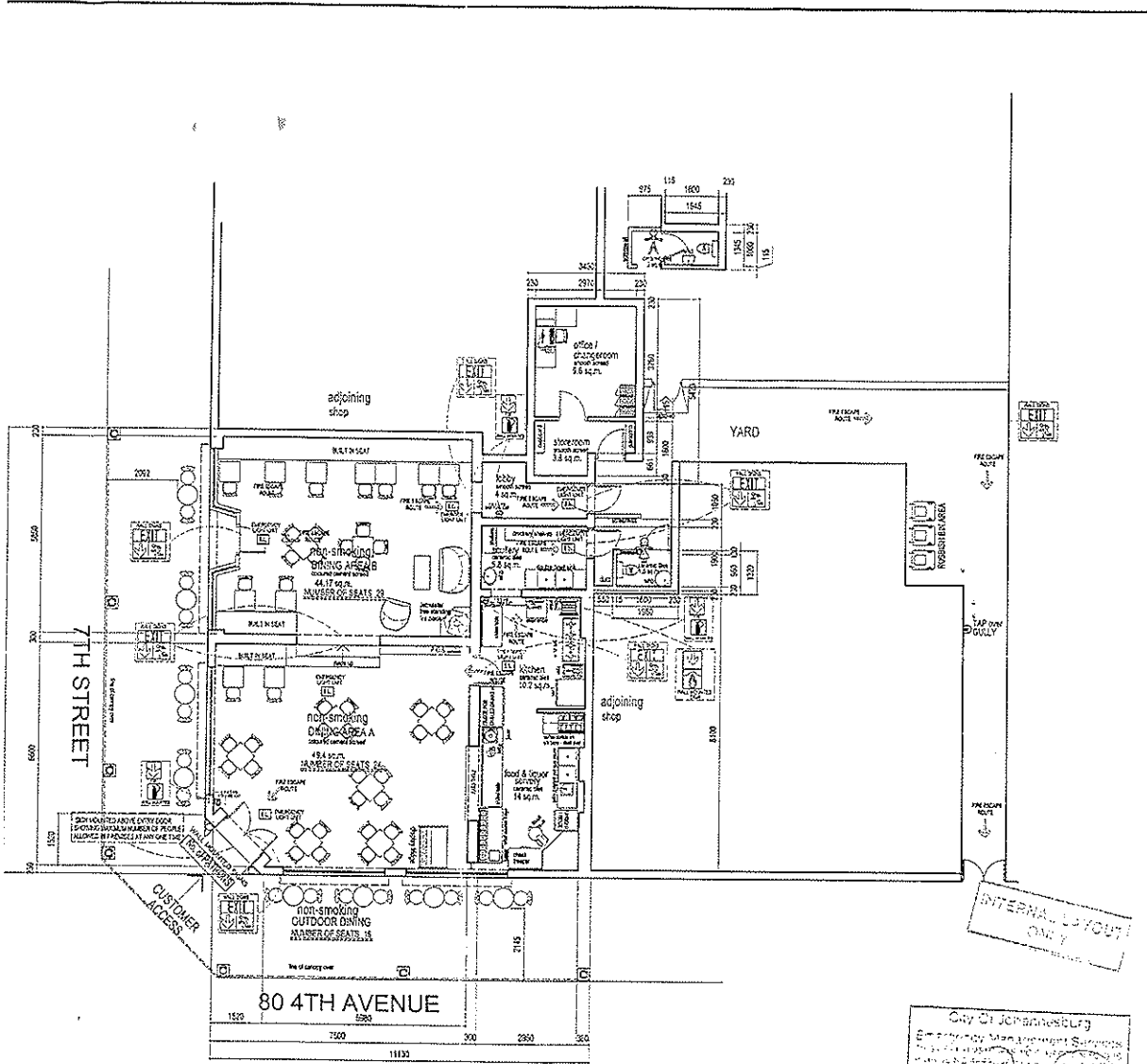

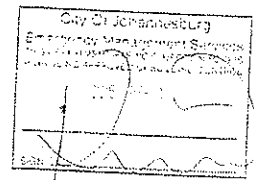
