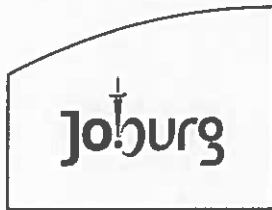
Noise Exemptions is also granted for the following Sound checks and Rehearsals:
